TRUSTEES:

a) The First Trustees shall be:

i. Sri. Ramachandra Narayan Nayak Road, Ankola, Uttara Kannada aged 55 years, residing at Aramane, , K C

ii.Sri. Mayur Ramachandra Nayak aged 26 years, residing at Aramane, , K C Road,

iii.Smt.Lata Ramachandra Nayak aged 43 years, residing at Aramane,,K C Road,

iv.Smt.Shruti Mayur Nayak aged 25 years, residing at Aramane, , K C Road,

b) Sri. Ramachandra Narayan Nayak shall be the Managing Trustee and Sri Mayur Ramachandra Nayak shall be the joint Managing Trustee and both shall hold Office for life or till voluntary retirement. In the event of the Office of the Managing Trustee becoming vacant, the Joint Managing Trustee will take over as the Managing Trustee. In the event of the Office of Joint Managing Trustees becoming vacant remaining Trustees may co-opt any one of them as the Joint Managing Trustee.

The other Trustees shall retire by rotation in two at a time, the first to commence three years from the date of the Trust Deed. The retiring Trustees will be eligible to

be co-opted for further periods.

d) The Managing Trustees and the Joint Managing Trustee shall at their discretion coopt any person/or persons who may be helpful in achieving the objects of the Trust as a Trustee.

e) The Maximum number of Trustees shall not exceed nine.

f) Trustees shall cease to hold Office of Trust on the Trustee becoming insane or lunatic or declared as insolvent.

MANAGEMENT

The Management, control of the property and affairs of the Trust aforesaid shall be vested in the Trustees with full powers and authority to purchase or hold any land or hereditament and construct any building for the object of the Trust or any funds or any other properties or investment at any time, subject to the Trust of these presents. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and charities as they deem fit and to later or vary the same from time to time to make new rules and regulations provided such rules and regulations shall not be inconsistent with the terms and intents of these presents and not inconsistent with the provisions of Sections 2(15), 11 to 13 and 80-G of the Income tax Act, 1961.

The Trustees shall meet as often as possible but not less than three times in a year b) for efficient management of the Trust, to consider the income and expenditure and

for disposing of all such other matters as may arise in such meetings.

At all meeting of the Trustees, two members shall form quorum. c)

At all meeting of Trustees, Managing Trustee or in his absence the Joint Managing d) Trustee or in their absence any other Trustee shall be the Chairman and all decisions of the Trustees shall be by majority vote, and the Chairman shall have a casting vote in case of equality of votes.
